It is the mission of the Tribal Gaming Agency to protect the integrity and assets of the Tribe's gaming facilities along with property and ensure the health and safety of all team members and customers.

Please be advised this application for certification is valid only for authorized Alabama-Coushatta Tribe of Texas gaming facilities. Providing goods or services to any location considered by the Tribe to be unauthorized, or in pending litigation with the Tribe concerning whether it is authorized, would be outside the approval granted through Tribal Certification. Vendors providing goods or services to unauthorized facilities may be subject to legal and/or regulatory risks.

Additional Information:

- This application is an official document, and false or incomplete answers could result in criminal prosecution and the denial, or subsequent revocation of a Tribal Gaming License. An application for a Tribal Gaming License may not be withdrawn without the approval of the Tribal Gaming Agency.
- All vendors shall be required to register with the Tribal Gaming Agency prior to conducting business with, contracting, or receiving payment from the gaming operation.
- Each non-gaming supplier that provides the gaming operation, by sale, lease, rental, or otherwise, non-gaming equipment, services or maintenance shall be required to register with the Tribal Gaming Agency as a Non-Gaming Supplier.
 - Non-Gaming suppliers with an annual invoice under \$25,000 will be required to register with the Tribal Gaming Agency and no fee is required.
 - Non-Gaming suppliers with an annual invoice amount between \$25,000.01 and \$300,000.00 will be required to register with the Tribal Gaming Agency and pay an applicable fee.
 - Non-Gaming suppliers with an annual invoice amount above \$300,000.01 will be required to register with the Tribal Gaming Agency and pay an applicable fee.
 - The annual invoice threshold shall be determined by a single transaction, contract, or cumulatively within a rolling twelve-month period.
 - Certain non-gaming suppliers may be given a waiver based on the services provided. Examples include utility companies, legal counsel, certified public accountants, and publicly traded companies. Waivers must be approved by the Tribal Gaming Agency.
 - The Tribal Gaming Agency may require the owner, principal, director, officer, employee, agent, or contractor of any supplier to undergo backgrounding, and shall pay the cost of any such investigation.
 - The Tribal Gaming Agency will issue a suitability determination (license) for any supplier subject to the background investigation requirement above.
 - Fill out the registration form in its entirety.
 - Submit the registration form along with your W9 and any unexecuted contracts or agreements.
 - Contracts and agreements must be reviewed by the Tribal Gaming Agency prior to being signed and/or executed.
